

Suit filed against LCRA

The Matagorda Bay Foundation and the Gulf Restoration Network filed suit in federal court in Houston on Oct. 19 to compel the Department of Commerce to issue rules to protect essential fish habitat under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens).

According to the suit, the Department of Commerce should have implemented the rule that was issued in 2015 to protect the estuaries and the flow of fresh water into the Matagorda Bay and the Gulf of Mexico.


